


HEIDELBERG is obliged to implement the Supply Chain Act within the Corporate Group beginning 01.01.2023

The GSCA places companies >3000 employees under the obligation to ensure compliance with certain human rights and environmental protection standards along their supply chains For the first time, this creates **binding rules** that German companies must follow in their supplier selection process concerning environmental risks and human rights



Within the scope of the GSCA for HEIDELBERG are <u>all</u> direct suppliers of <u>all</u> product groups at <u>every</u> location worldwide






The aim of the GSCA is the reduction of risks for humans and the environment along the supply chains








The GSCA process steps at a glance


