

**HEIDELBERG PHILIPPINES, INC.
WEB SITE TERMS AND CONDITIONS OF USE**

1. USERS

Heidelberg Philippines, Inc. ("**Heidelberg**" or "**Us**") owns, controls and operates this website (the "**Site**") from its Head Office in Makati City, Philippines.

PLEASE READ THESE TERMS AND CONDITIONS OF USE CAREFULLY. By accessing or using this Site, you are agreeing to be bound by these terms and conditions. If you do not accept these terms and conditions, do not access or use this Site. From time to time, Heidelberg may change these terms and conditions and you should visit this page to review these terms and conditions whenever accessing or using this Site. Your use of the Site, or any service or product offered on this Site after the posting of changes to these terms and conditions of service will constitute your representation, warranty and covenant that you have the capacity to enter into this agreement and YOUR ACCEPTANCE OF THE TERMS AND CONDITIONS OF USE, as modified.

Retention of goods beyond 7 working days after shipment constitutes acceptance of all terms, conditions and prices including, if applicable partial shipments, and said conditions are agreed to by buyer, unless immediate notice is given in writing, and the packing slip/return slip returned for correction to Heidelberg Philippines, Inc. 2231 Chino Roces Avenue, Makati City 1221. Heidelberg does not guarantee the availability or replacement of service parts or consumables.

(b) **Product Availability and Information:** Delivery is subject to availability. Out of stock items will be shipped as soon as possible. All illustrations, photographs, and specifications within this website are based on the latest product information available at the time of publication. Heidelberg reserves the right to make changes at any time, without notice, to prices, descriptions, images and policies. Heidelberg reserves the right to limit quantities.

(c) **Product Warranty:** Seller warrants to the original Buyer as follows

(i) **Consumable and Spareparts Products:** All consumable and spareparts products sold by Heidelberg Philippines carry the manufacturer's warranty only.

EXCEPT AS STATED ABOVE, THERE ARE NO WARRANTIES OR CONDITIONS EXPRESS OR IMPLIED. (d) **LIMITATION OF LIABILITY:** BUYER IS EXPRESSLY NOTIFIED AND HEREBY AGREES THAT SELLER'S LIABILITY AS TO ANY CLAIMS ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT OR THE SUBJECT MATTER THEREOF SHALL IN NO EVENT INCLUDE ANY LOSS OF ANTICIPATED PROFITS, COSTS OF COVER, SPECIAL OR CONSEQUENTIAL DAMAGES.

(e) **Delivery Lead Time and Charges:**

Our office business hours are from 8:00am to 5:00pm, Monday to Friday except on legal holidays. For on-stock consumables & spareparts, delivery is within 24 hours upon receipt of confirmed order with daily order cut-off time of 4:00pm. Otherwise, standard factory lead time applies. For minimum order of PhP 10K, free delivery to Metro Manila and Metro Cebu accounts only. Customers may opt to pick-up from Heidelberg Philippines all items below the minimum order amount and urgent requirements. For non-available spareparts, delivery is 8 to 12 working days upon receipt of the confirmed order. All deliveries are subject to credit verification.

(f) **Payment Terms:** All credit orders are accepted by Heidelberg subject to satisfactory credit approval. Where credit approval has not been granted, payment in the case of goods is required prior to delivery. Where credit has been granted, official credit terms applies. Payment is to be made in full & without set off or deduction. Any disputed invoices will be investigated, and if resolved in favour of the Buyer, a credit will be issued. Interest at the rate of 1.5% per month will be charged from due date of all invoices.

(g) **Title:** In no event shall title to the goods or any portion thereof pass to the Buyer until the Buyer has fulfilled all of its obligations under this agreement including without limitation payment in full to Heidelberg of the total purchase price plus any other amount owing to Heidelberg from the Buyer under this or any other contract but the goods or any other part thereof delivered shall be at the Buyer's risk from the time of delivery to its premises and the Buyer shall indemnify Heidelberg against all loss to or damage of the goods from whatsoever cause occurring after such time. The Buyer will insure the goods in the name of Heidelberg for the full price of the goods until payment to Heidelberg of the whole purchase price.

h) Return of Goods:

If the Goods delivered:

- i) Are not the Goods ordered by the Buyer; or
- ii) Are damaged

The Buyer may return the Goods to Heidelberg without cost provided:

- iii) The Buyer requests from Heidelberg within 7 days of the date of delivery and Heidelberg grants a Return Authorisation;
- v) The Goods are in their original packaging unopened and otherwise in a saleable condition and show no sign of damage

Returns after 7 days will not be accepted.

Risk in the goods remains with the Buyer until the goods are received by Heidelberg. Return of goods will be at the Buyer's expense.
